

New York State Decentralization Grants Awarded for Cultural Programming in 2012

Fifteen Sullivan County non-profit organizations received \$17,500 in Decentralization Grants (DEC) for 2012 cultural programming at a special awards ceremony on Saturday, February 18, 2012 at the Delaware Arts Center in Narrowsburg, NY. Representing NYS Senator John Bonacic was Joe Ann Drake, who read a prepared statement from Senator Bonacic thanking the grant recipients for their contributions to the cultural life of Sullivan County. Allocated by the New York State Council on the Arts, the funding is administered by the Delaware Valley Arts Alliance (DVAA). The granted organizations represent nine townships throughout Sullivan County, including the Towns of Callicoon, Delaware, Fallsburg, Forestburgh, Highland, Liberty, Lumberland, Rockland, and Tusten,.

Granted organizations are:

Callicoon Center Band for a summer concert series; Cornell Cooperative of Sullivan County for art workshops; Delaware Valley Chamber Orchestra for a local composers series; Delaware Youth Center for art and theatre workshops; Friends of Sunshine Hall Free Library for winter cultural program; Icehouse Arts for three youth video workshops; Liberty Free Theatre for theatrical production Liberty Museum and Arts Center for a jazz festival Roscoe Free Library for watercolor workshops Sullivan County Community Chorus for two concerts; Sullivan County Historical Society for a vaudeville production; Sullivan County Historical Society for a series of coffeehouse concerts; own of Fallsburg for two free Chamber Music at St. Andrews concerts; Town of Lumberland Cultural Series for two concerts; Western Sullivan Public Library for an oral history project

Found Money! - A Billion-Dollar Bonanza Could Await Ulster County

Ulster County Comptroller Elliott Auerbach alerted dozens of local governments, school and fire districts, little leagues, ambulance corps, local courts and police departments in the county that there is money waiting for them as part of the Office of the State Comptroller's (OSC) unclaimed funds account. The total being held by the State is close to \$11 billion dollars for over twenty-six million accounts.

result of unclaimed funds from dormant bank accounts, insurance benefits, trust funds, estate proceedings and other idle holdings that have been surrendered after two to five years of account inactivity. "We have identified and contacted numerous organizations and governments in the County, including entities like the Woodstock Fire Department, the Marlborough School District, the Town of Shandaken and the Rondout Valley Little League informing them that there is money waiting to be claimed on their behalf," Comptroller Auerbach said. "New York State holds these unclaimed funds in a trust, and OSC has processed more than 600,000 claims and has paid out approximately \$296 million dollars," according to Auerbach.

Comptroller Auerbach stated "this is not only an opportunity for local governments, not for profits and community based organizations, but for individuals as well. OSC boasts that the largest personal account paid was for \$4 million dollars and is currently holding an unclaimed individual account of \$1.7 million dollars. Before you get your hopes up to high I would just like to point out however, that 63% of the claims have been less than \$100.00."

This action has allowed the County to save taxpayer dollars in the face of state aid cuts to the Youth Bureau Department.

Additionally, County Executive Hein announced that he will appoint Evelyn J. Clarke to the positions of Youth Bureau

Director and Human Rights Commissioner. Evelyn has great experience with community advocacy and youth work. In addition to her advocacy work, Evelyn is uniquely qualified to mange the administrative aspects of these two County departments having worked 27 years for IBM.

In addition to her work for IBM, Evelyn has worked at the NYS Division for Youth, the Community Partnership Training program, counseling at-risk youth for job skills. Evelyn has also held a number of community service positions on a volunteer basis.

Evelyn holds a Bachelors degree from SUNY New Paltz and a Masters of Public Administration Degree from Marist College. She currently resides in Esopus, with her husband Reverend Modele Clarke. (Contd. Pg. 4)

Searching For Our Roots

Old clippings are often great resources for nuggets of history. In the early 1960's, it was fun to read about a Grahamsville Methodist Church supper. It seems the ladies were tired of the traditional suppers and decided to serve a Swedish smorgasbord. Swedish meatballs were on the menu along with many other dishes, some Scandinavian and some good old Grahamsville dishes.

Eighty-eight people attended and the ladies cleared \$75. Prices charged were Adults \$1.25. Children 75 cents between the ages of 12 and 5 and under 5 - Free. Can you imagine being able to buy a

meal for less than \$2?

Gloria Thompson of Florida weighed in on the tavern in Hasbrouck, which was mentioned as being the attraction for Phineas Booth. She reminded me to go to Quinlan's and read the chapter on Town of Fallsburgh. There it told about Matthew, son of Conrad Sheeley, being the proprietor of the first tavern in Hasbrouck.

Thinking of Hasbrouck brings me to a question that continues to pop up in my mind. Two different individuals have told me stories about the site where the Old Stone House is in Hasbrouck. Each has to do with an early section of the house being used as a fort. Others tell me this could not be true. Dear readers, let me know if you have any pertinent information. Don't forget, Hasbrouck and all that section of Fallsburgh were part of the Town of Neversink until 1826 when the Town of Fallsburgh were created.

Our neighboring reservoir, the Ashokan, is the subject of an archival exhibit on the second floor of the Ulster County Office Bldg, 244 Fair St, Kingston. A portion of their Ashokan Collection is on display from 9 to 5 weekdays through April 30th. For more information contact the Ulster County clerk's office at 340-3040 or visit her web page at

The rise of digital cameras is blamed for the fall of film-loaded cameras. We are reminded that the Kodak camera was launched in 1888. It was the year 1900 when the Brownie camera was introduced at a cost of \$1. Margaret Smith Dolan tells us that the reason for so many photos being available of the Upper Rondout including Eureka, Montela and Lackawack areas is that the Kodak people came through and gave cameras away. My Mom had a huge stash of snapshots from the 1920's that she had taken with a Kodak. Now instead of photo albums,

one has chips or disks with all the family photos on

them. Times do change.

Joe Weise has been a great help in writing down tidbits of local history from time to time. In one collection that he sent me - he quotes Percy Bunton as saying "half your wood and half your hay you must have on February's second day" (when you cooked and heated your house year-round). Joe goes on to say, "Percy Bunton came in one blustery day - shiv-ering and wearing only his light barn coat." Joe reports that Percy's comment was "winters comin and I aint got enough clothes on to wad a shotgun." If you have any favorite old sayings, I invite you to send them along to me.

Donations come in almost weekly for our research center and our museum collections of artifacts. Recent donations to the research center include a two-volume genealogy of "The Van Valkenburg Family in America" as compiled by Paul I. Van Valkenburg and "The Ancient Records of Norwalk, Conn." published in 1847. The Norwalk records include all early settlers there. I recognized the names of Hanford and Fitch but certainly there are others who came from there as well.

There is a lot going on in the museum. There is a 7th grade group called the "Junior History Researchers" from TVCS who are working on an oral history project. They are meeting every other week at the museum. Right now, they are trying to contact members of the Class of 1952, teachers and

other school staff from that time period.

The watershed floor is being completely rebuilt by Dave Forshay and Jack Clark. That floor will tell the story of the watersheds under the able direction of Donna Steffens, Museum Director and Barbara Purcell, Chair of the Exhibit Committee. There is still a need for artifacts from the building of the reservoirs and photographs.

An exhibit titled "The Family Farm" will fill the upper level exhibit space. Dorothy Muthig is chairing that committee. The museum is planning to

open on May 5th.

Canoes, kayaks and sailboats will be allowed on the Pepacton, Schoharie and Neversink Reservoirs this year! The NYC DEP has agreed to allow nonmechanized boats on these man-made lakes in a multi-agency effort to increase tourism and the general quality of life in the region. Boating will be permitted from Memorial Day through Columbus Day. The CWC will help fund the program by renting portable toilets to be placed at launch sites which will be developed by the DEP (three on the Pepacton, and two each on the Schoharie and Neversink). The CWC will also subsidize equipment needed to steam clean boats (mandatory), and will soon advertise for vendors who would like to provide, and charge a fee for, this service to boaters; watch the CWC website for the bid announcement.

This expansion of recreational boating follows a successful 3-year pilot program on the Cannonsville Reservoir, where boating will continue from seven launch sites.

Boaters will be able to get to the Schoharie Reservoir from Prattsville when the NYC DEP opens 126 acres of City-owned land just downstream of the hamlet. DEP land on both sides of the Schoharie Creek north of the Route 23 bridge will be open to the public May 1, and boating on Schoharie Reservoir will be permitted starting May Parking areas will be provided on both sides of the creek, and a boat launch will be installed on the Rt. 23 shoreline. The entire area was previously accessible only to anglers with permits and now will be reclassified partly as a Designated Use Area and partly as a Public Access Area. The Designated Use area will be around 41 acres and will be used for "Passive Use," such as walking, picnicking, fishing, nature study, etc. with no permits required. About 83 acres will be reclassified as a Public Access Area which allows hunting, fishing, trapping and hiking, also with no permits required.

Contractors hired by the DEP last fall removed countless tons of flood debris from the creek and its banks, increasing the area's accessibility. The move by DEP is intended to assist in the recovery of flooddevastated Prattsville by attracting recreational visitors and providing an opportunity for boaters to take advantage of an upstream access point for the newly opened Schoharie Reservoir. It also offers a business opportunity for steam cleaning and boat rental

vendors.

The Feisty Fisher

By Peggy DeWire tened to my friend Betty's troubled voice. "Hi Peggy voice, "Hi Peggy. Something has been taking our barn cats here on the farm and today Jim and I saw the

cuprit but we don't know what animal kin of ani-

mal it is."

She went on to describe a great big weasel with a bushy tail, silky dark brown fur and a cat face.

I said, "Betty, you and Jim saw a fisher, a deep woods animal rarely seen by people even though it hunts both night and day.

FISHER At her urging, I told her that fishers once ranged over most of the



United States but had been trapped almost to extinction for their beautiful thick brown fur. Nowadays they are making a comeback statewide in places in forests like the Catskills. And they are helped by the protection of a limited trapping season, October 14th to December 10th.

Fishers (Mortes pennanti) of the weasel family are solitary agile hunters on both the ground in trees. Over a ten-mile square home range, they feed on small animals, fruit, beries, carrion and fern tips. Fishers and Martens (their little cousins in the weasel family) can elongate their bodies to squeeze into small holes in the ground and hollows in trees for prey.

Fishers just might be the fastest animals in the treetops. Woodsmen have told me that martens catch squirrels on the run and fishers catch martens.

A favorite fisher food is a porcupine up a tree which a fisher can skillfully overturn so fast tht it avoids the sharp dangerous quills on the back and tail and exposes the soft unprotexted underbelly.

Fishers are good swimmers, but don't catch fish, which makes me wonder how they got named.

This valuable fur bearer grows two feet long with a bushy 14" tail. Its beautiful dark brown pelt has white-ripped guard hairs giving its body a frosted apearance. It has five toes on each foot with retractable claws like cats.

Fishers breed in spring and 1-5 young are born a year later. The embryos don't develop through this long gestation but have a spurt of growth a month before birth. This phenomenon is called delayed implantation and occurs in black bears, armadillos and weasels. The female breeds again soon after birthing so she is pregnant most of her lifetime.

She raises her babies in a den hole in a tall tree and may move them several times to other dens if disturbed. About three months later she has taught her little ones to be speed tree climbers and equally fast ground hunters.

Fishers are solitry, feisty animals that communicate by scent marking brush piles, ground burrows and trees in their territory. In winter they tunnel

in the snow to make dens.

Fishers live about ten years and have few enemies except men who are trappers or lumberjacks who cut down whole forests. Since fishers are the only animals that consistently prey on porcupines which debark and kill tress, I find it ironic that timber men degrade fisher habitat.

I told Betty and Jim that their feisty fisher would very likely move on to another spot in its ten-mile square home range. And soon, since it doesn't like human contact.



We're continuing with serials this week . . . and no Mikey . . . they're not the kind you pour out of a box and eat for breakfast with milk and a spoon. These are serial stories, like you see on TV, where each installment ends with a cliff-hanger, so you'll be eager to watch the next installment, to find out, what happens next?

In that spirit, this week's MBR 38 will continue the review of Duane Swiercyznski's "insanely entertaining" Charlie Hardie series, with the second book of the trilogy, titled Hell & Gone (Mulholland, \$14.99, 286 pages, ISBN 978-0-316-13329-6).

At the conclusion of book one, Fun & Games, Charlie Hardie was shot, wounded and left for dead in a shoot-out with the Accident People after he exposed their billion-dollar scheme. As book two, Hell & Gone begins, Charlie has been kidnapped and drugged, by the Accident People, kept in a coma, and treated for his injuries. When he awakens, he is trapped in a secret underground prison, where he's the warden, in charge of the most dangerous criminals on earth. It reminded me of the stories of Frank Kafka, which I loved reading in college. And all the action I've just described occurs in the first 100 pages! Like all pulp fiction, it's an unbelievable thrill-ride from the very first page. I found it irresistible and great fun to read. If you're starting to think it's almost like a comic book, well, you're right. Swierczynski's day job is at Marvel Comics. Like comics, Hell & Gone is fast-paced and entertaining, but more enjoyable to my way of thinking, because it's longer and without drawings that distract your attention. You have to use your imagination. I like that, and I liked the books. The last of the trilogy is due next month. The title is

Point & Shoot, and I'll review it shortly thereafter.

If you see Mike Curley around town, ask him about all the great books he gets at the new Daniel Pierce Library in Grahamsville. He'll tell you how he's gone from "I don't read much, no time," to "I get two or three books at a time," and reads them in two weeks . . . and goes back for more! I may even send him a star

for being such an outstanding reader.





From Assisting Crime Victims to Beina a Victim of Crime - Unaccounted For Cell Phone Racks Up 17,000 Minutes In Two Months

Ulster County Comptroller Elliott Auerbach revealed that a recent claims audit of cell phone charges for a county phone assigned to the ULSTER COUNTY PROBATION DEPARTMENT'S CRIME VICTIM 'S ASSISTANCE PROGRAM uncovered a missing phone which resulted in probable theft of services when it was discovered that the usage went from little or no monthly charges to over 10,000 minutes in a single month's billing cycle resulting in a total usage charge of \$1063.00. The prior month's usage was over 7000 minutes and ran up usage charges in excess of \$780.00.

"After our review and with the assistance from both the PROBATION DEPARTMENT and INFORMATION SERVICES it was discovered that the chain of custody for this particular wireless device was broken and it looks as if the County has suffered as a result of this abuse of taxpayers' money. While I realize that the losses appear to be minimal, my office is committed to insure that every dime and dollar of taxpayers' money is being prudently spent," said Comptroller Auerbach. "I have spoken with District Attorney Holley Carnright and have turned over my findings to his office to determine if there are possible criminal charges" said Auerbach.

The Comptroller was very critical of county cell phone use and policy in a June 2009 report entitled THE COST OF CONNECTIVITY when he examined cell phone cost and found the controls ineffective and made numerous recommendations for cost containment. "It's time for the policy makers to revisit county cell phone use, reduce the hundreds of devices that are county issued, and provide a monthly allowance for those employees who use their personal cell phone for county business" Comptroller Auerbach suggested.



Attorney General Schneiderman Secures \$2 Million in Settlement With Companies that Tricked Consumers into Signing Up for Online Discount Clubs with Hidden Fees - Vertrue And Adaptive Marketing To Pay \$2 Million In Refunds To New Yorkers Who Were Duped While Shopping Online

Attorney General Eric T. Schneiderman today announced a settlement with Vertrue Incorporated and its subsidiary, Adaptive Marketing, LLC (collectively "Adaptive") to provide \$2 million in refunds to New York consumers who were tricked into enrolling online in Adaptive's discount club programs and then charged hidden fees. Adaptive also agreed to reform its online

marketing practices.

"This scheme tricked thousands of New York consumers into unknowingly signing up for memberships programs they did not want or need," said Attorney General Schneiderman. "The discount-club seller Adaptive profited by luring consumers with enticing but deceptive offers that included hidden membership fees. This settlement helps make the Internet a safer

place for consumers to shop.'

The Attorney General's investigation found that Adaptive entered into arrangements with many well known retail companies, such as Classmates, Intelius and VistaPrint, that permitted Adaptive to solicit the companies' customers by offering discounts, rebates, or other incentive offers while the customer was shopping online. When a consumer accepted what he or she thought was the retailer's online offer, the consumer was unknowingly transferred to an Adaptive webpage and automatically enrolled in Adaptive's fee-based membership program. Because Adaptive obtained a consumer's credit or debit card account information from the retail partner, consumers were not required to re-enter their credit and debit card numbers and were unaware that they were being enrolled in Adaptive's fee-based membership program.

After a brief "free trial" period, Adaptive would charge the consumer's credit or debit card approximately \$15 or more monthly until the consumer proactively canceled the membership. Consumers often incurred these fees for months on end without realizing that they had been enrolled in these programs. Even after consumers noticed these charges on their credit or debit card statements, many experienced difficulties cancelling the fee-based programs when they contacted

Adaptive for that purpose.

Information about joining Adaptive's discount club program, the monthly fees, and the secret transfer of the consumer's credit or debit card account information was buried in fine print and cluttered text on the webpage so that most consumers were not aware that by accepting the discount offer, they were being enrolled in Adaptive's fee-based programs. Few "members" of these programs actually used any of the programs' offered discounts and benefits, presumably because they did not know they were enrolled in the programs.

As part of the settlement with Attorney General Schneiderman's Office, Adaptive agreed to implement important reforms to protect New York's online shoppers from being deceived by discount and cash-back advertisements. These reforms require Adaptive to: -Ensure that consumers understand that that they are

enrolling in an Adaptive membership program; -Require consumers to enter their full credit or debit card numbers and other billing information on the discount club seller's enrollment page before enrolling the consumer in an Adaptive membership program;

 Warn consumers that the incentive being offered is for joining a separate company's membership club; -Notify consumers when they are redirected to a dis-

count club seller's site that they are leaving the original

retailers' websites;

-Provide a consumer-friendly exit, such as a "No Thanks" button, from any discount club seller's solicitations that interrupt the completion of the consumer's transaction with the original retailer.

A number of these reforms go further than the federal Restore Online Shoppers' Confidence Act ("ROSCA"), which banned the practice of third party sellers obtaining consumers' billing information directly from the retailer, a practice commonly referred to as "data pass," effective December 29, 2010.

New York consumers who were unknowingly enrolled in an Adaptive program via data pass between January 1, 2007 and January 31, 2010 (Adaptive stopped using data pass in January 2010) will be eligible to receive refunds through a notice and claims process that will be administered by an independent entity supervised by the Attorney General's Office.

In addition, Adaptive is required to provide a refund to any New York consumer who was enrolled in an Adaptive program via data pass at any time and informs the company they were unknowingly enrolled in the program and/or were charged a membership fee without their knowing authorization, with certain conditions. Refunds are also available for consumers who were not allowed to cancel their membership upon

Adaptive's membership programs include: 24Protect; At Home Rewards; BusinessMax; DealMax; Passport to Fun; Privacy Matters 1-2-3; Privacy Matters Identity; Privacy Plus; SavingsAce; SavingSmart; Shopping Essentials; TodaysEscapes;

ValueMax; and Your Savings Club;

The Attorney General's office has previously reached agreements with major discount club sellers Webloyalty, Affinion and Encore Marketing, as well as a number of well known retailers that partner with Adaptive and these other discount club sellers.

What Consumers Should Do to Protect Themselves Against Unauthorized Charges:

Consumers should carefully review their credit and debit account statements each month to ensure that all charges have been authorized. Consumers who discover unauthorized charges from discount club sellers should call the 1-800 number listed with the charge on their account statement to cancel their membership and/or request a full refund. Consumers should also inquire whether they are members of any other programs from that particular seller in order to ensure they cancel all memberships and/or receive all refunds. Consumers should carefully read the fine print provided with any discount or service offers, particularly when shopping online. Seemingly attractive "free" or "limited trial" offers often come with significant strings

attached.

Defense Cuts Endanger Our National Security

The 2013 Defense Department budget cuts mili-tary spending by \$487 billion over 10 years, which translates into eliminating six Air Force fighter squadrons, cutting 16 ships from the Navy, and reducing the Army and Marine Corps by 80,000 to 100,000 troops over five years. Our thinking is that future wars will be fought with more high technology weapons and fewer troops. The problem is we could lose highly qualified military personnel because of the cutbacks. The end result could mean we will have a plethora of high technology weapon systems available, but lack the quantity and quality of non-commissioned and commissioned military leaders to employ the equipment.

Another \$600 billion in defense cuts could be

enacted if Congress does not act to change current

Unfortunately, our military strategy might be faulty. Let's look at a few countries who could be potential adversaries.

China has a multi-million man army and a large air force. It is upgrading its missile systems and developing anti-ship missiles that could threaten U.S. naval forces. It is in the process of deploying two aircraft carriers and building up its submarine fleet. China seeks to dominate Southeast Asia and wants to annex Taiwan. It is a close ally of North Korea.

North Korea has a million man army and continues to expand its missile capabilities. It poses a threat to South Korea, and maintains a goal of uniting Korea under its domain. It has nuclear weapons and continues to sell nuclear and missile technology to a number

of countries, including Iran.

Iran threatens the Middle East region with an aggressive attitude and the potential development of nuclear weapons. It has missile systems capable of hitting targets in other Arab countries, Israel and Western Europe. Iran has acquired some submarines and is building up its navy. It has a close relationship with Venezuela and might want to establish a naval base in that country.

Venezuela threatens South American and Central American countries. President Chavez is friendly with Castro of Cuba, and has developed a military relationship with Russia. He has purchased a significant quantity of arms from Russia and has allowed Russian war-

ships to use Venezuelan port facilities.

Russia is a Communist country that could still threaten world peace. It supports Iran's nuclear program, and it is upgrading its land military forces with the latest weaponry and is refurbishing its navy.

Another concern for the U.S. is the potential rise of radical Islamists in a number of countries in North Africa and the Middle East. As the totalitarian governments in the region fail, they could be replaced with Islamic forces who might implement Sharia law and who could be antagonistic and possibly adversarial to the U.S.

The weakening of the U.S. military with the proposed budget cuts could embolden potential adversaries to expand militarily in their respective regions. We need to maintain a strong military posture to protect our national security and promote peace in the world by deterring potential adversaries from launching military adventures.



In his address, the County Executive

announced the following initiatives:

Citizen's Access: To provide citizens increased transparency and access to pertinent information about Ulster County government, County Executive Hein has created an entirely new section of the County website which includes data from County purchasing contracts, a directory of County officials with hyperlinks, the entire County budget, County financial statements, and a summary of County take home vehicles.

Emergency Operations Center: Following the devastation of Hurricane Irene and Tropical Storm Lee, the County Executive, in cooperation with his Office of Emergency Management & Communication, the Fire Coordinator and Ulster County Sheriff Paul Van Blarcum is moving forward to establish a fully integrated and operational Emergency Operation Center (EOC) to be located at the Ulster County Law Enforcement Center. The EOC will be a central command and control location, which will collect, gather and analyze data and allow County officials to make informed decisions designed to protect life and property. During emergencies, it will serve as the central source for critical disaster-related information for the people of Ulster County.

Veterans' Housing: There are a growing

number of homeless veterans in the United States, a trend that is a national disgrace. The County Executive requested the Legislature's cooperation to identify a property and convert it into high quality, dignified transitional housing for Ulster County's homeless veterans.

Child Health Plus: In New York, there are two different public health programs for kids, Child Health Plus and Medicaid coverage for children. They are comprehensive health insurance programs that cover a wide range of children's health and dental needs. About 10% of Ulster County's children are currently uninsured. The County Executive set a goal to reduce the number of uninsured children by enrolling those eligible in these programs, because far too many children are going without basic healthcare.

The "President's House": Ulster County currently owns a luxury home situated on several acres of land and valued at over a half a million dollars. The home, known as the "President's House" is not used as a residence by the Community College President, yet County tax-payers must pay to maintain it. With the support of Ulster County Community College President Don Katt and the Executive Committee of the College's Board of Trustees, County Executive Hein proposes selling this luxury home and using part of the proceeds to fund the new Veteran's transitional housing.

Space Utilization: Since County Executive Hein took office, there has been a 10% reduction in the Ulster County workforce. As a result, the County should now reevaluate how best to utilize its existing space. Additionally there are currently over 70 separate properties owned by Ulster County. The County Executive therefore requested that a joint Executive/Legislative Taskforce be created with the mission of evaluating the County's properties and getting as many as possi-

ble back on the tax rolls.

First Time Home Buyers Property Tax **Exemption:** In order to rebuild access to the American dream, the County Executive has proposed, in accordance with New York State Real Property Tax Law, a County partial property tax exemption for first time home buyers purchasing new or renovated homes. With this proposal, Ulster County can aid County residents and attract new residents by promoting home owner-ship. This initiative, if adopted, can create new construction jobs, generate demand for durable goods and strengthen local communities in Ulster County.

In addition, the County Executive announced that the County will save \$3 million for the taxpayers of Ulster County by refinancing long-term bonds that were primarily used to fund the con-

struction of the jail.

"Our commitment to financial responsibility has long-term benefits. In January, Moody's Investor Service reaffirmed the County's strong bond rating. Additionally, Standard and Poor's and Fitch Investors have recently done the same. Because of Ulster County's continuing strong bond ratings, we have been able to refinance bonds, saving taxpayers millions in the process,' said County Executive Hein.

The County Executive detailed the following initiatives and respectfully requested the Ulster County Legislature's assistance to:

Hein Outlines an Ambitious -Advocate for meaningful mandate relief from the State Legislature;

-Approve the tourism shared services agreement with the City of Kingston;

 Provide clean and dignified transitional housing for our homeless veteran population;

-Identify families whose children can benefit from Child Health Plus;

-Approve the sale of the college's "President's House";

-Support the review and sale of non-essential County real estate holdings;

-Pass the First Time Homebuyers Exemption; -Partner with the County Executive to redesign Economic Development;

-Address the financial liability of the Resource

Recovery Agency; and

-Partner with the County Executive to design a comprehensive, multi-year solution for Safety Net.

County Executive Hein said. "As County Executive, I have had the opportunity to speak to thousands of our residents. What they have told me is that they love this country and they want their government to live up to the principles of our forefathers. In Ulster County, since we've changed our form of government, we have a unique opportunity to be different. We have an opportunity to set aside the poison of partisan politics and to deliver the type of integrity-based government the people so richly deserve.

Hinchey Blasts Postal Service for Planned Closure of Mid Hudson Mail Processing and Distribution Center Immediate Bipartisan Congressional Action is Crucial to Saving Jobs

Kingston, NY -- Congressman Maurice Hinchey (D-NY) today vowed bipartisan congressional action to fight against the proposed closure of the Mid Hudson Processing and Distribution Center located in Newburgh, New York. The facility was included on a list of 223 processing facilities slated for closure by the U.S. Postal Service (USPS) starting in May 2012. Hinchey has been a staunch opponent of closing the Newburgh facility, which employs 385 workers. He is also working to pass legislation to address the underlying financial troubles faced by USPS.

"The Postal Service has failed to justify the proposed closure of the Mid Hudson Processing and Distribution Center in Newburgh, and I'm going to do everything I can to block their efforts," said Hinchey. "They've said publicly that a closure moratorium is in place until May, but they're already laying the groundwork to shift around resources and workers. They've said that consolidating the facility will save money, but they have yet to publicly release the data or the assumptions that caused them to arrive at this conclusion. In fact the only way to consolidate these facilities is to lengthen first class delivery times, making USPS even less competitive. Closing the Newburgh facil-

ity would be a huge mistake. We need immediate

bipartisan congressional action or else hundreds of

workers will lose their jobs and postal services

throughout our communities will be downgraded." In August 2011, Hinchey urged Postmaster General Donahoe to prevent the closure of the Newburgh facility after the USPS initiated an Area Mail Processing (AMP) study to consider consolidation with a similar facility in Albany, New York. Hinchey offered official comments opposing the potential closure of the facility on December 1, 2011. Later that December, Hinchey sent another letter to Postmaster General Donahoe signed by 37 other House members opposing the proposed closure of mail processing and distribution centers nationwide.

Hinchey is a cosponsor of legislation designed to help ease the financial challenges currently faced by USPS. The United States Postal Service Pension Obligation Recalculation and Restoration Act of 2011 (H.R. 1351) would free up billions in financial resources for USPS for years to come. Under current law, the Postal Service is required to pre-fund health care benefits of future retirees at a cost of over \$5 billion annually. H.R. 1351 would help reduce the financial burden of this requirement by allowing the Postal Service to use billions of dollars in overpayments to their pension fund to pre-fund healthcare benefits of future retirees. The legislation is strongly supported by the National Association of Letter Carriers.

Hinchey has also joined several of his U.S. House colleagues in introducing the Postal Service Protection Act - legislation designed to alleviate the U.S. Postal Service's (USPS) immediate financial crisis and prevent the layoff of thousands of USPS employees nationwide.

DiNapoli: Former Welfare Fraud IG Investigator Convicted of Stealing \$5,000

A former investigator with the State Welfare Inspector General's Office pleaded guilty to illegally obtaining unclaimed funds following an investigation launched by New York State Comptroller Thomas P. DiNapoli. Gabriel Camacho, prosecuted by the Manhattan District Attorney's office, was sentenced on February 21 to community service and ordered to pay restitution.

"Fraud is fraud, but it is particularly egregious when it is committed by a public servant charged with investigating fraud," DiNapoli said.

As State Comptroller, DiNapoli is custodian of \$10.5 billion in abandoned property or inactive accounts turned over to the state by banks, insurance companies, utilities, investment companies and many other businesses as required by state law. The Comptroller's Office of Unclaimed Funds holds the accounts until they are claimed by the rightful owners.

DiNapoli's investigation found that Camacho had submitted 15 forged abandoned property claims totaling nearly \$5,000. Camacho resigned from his \$62,597 position with the state on

August 26, 2011.

LIBERTY. - NY - Congressman Maurice Hinchey (D-NY) today joined with local officials to announce an \$800,000 federal investment to allow the construction of the Southern Catskills Red Meat Processing Facility to move forward. Hinchey was instrumental in securing the \$800,000 in funding, which was awarded through the U.S. Department of Commerce Economic Development Administration (EDA) to the Sullivan County Industrial Development Agency (IDA). "This federal investment will create jobs, promote economic development in our area, and most importantly, help local family farms stay in business and grow," Hinchey said. "Federal investments such as this one are so critical to supporting regional agriculture, which remains an important industry throughout the region and our state. It is vital that we continue to invest in programs that promote family farms and the economic opportunities they bring to rural areas such as Sullivan County." The facility is expected to support the creation of more than 50 new agricultural jobs and three to five direct jobs at the plant itself. At a time when consumer interest has grown dramatically in local food production and naturally-raised livestock, Sullivan County and the Catskills are wellpoised to tap the expanding markets for these products, particularly in the New York Metropolitan area where restaurants and farmers markets are helping to make the link from farm to table for agricultural products from our region. Currently, farmers in Sullivan County and surrounding counties in the Hudson Valley have to travel two to four hours one way to bring livestock to market, often having to wait months just to be scheduled for processing.

Six miles as the crow flies, to the northwest of Warwarsing is the dam and gatehouse of the

Rondout reservoir, one of the last links in a chain of reservoirs built by the City of New York in the '30's, '40's and '50's to supply fresh drinking water. The Rondout, which is seven and a half miles long and contains about fifty biflion gallons, collects water from three streams and three other reservoirs, Pepacton, Cannonsville and Neversink, then sends it ninety miles south to the City via the Rondout West Branch Tunnel. Sitting at the dam is the Gate House. It controls and regulates the flow of water down the twelve-foot tunnel, which passes straight through Warwarsing, six hundred fifty feet below John and Betsy Tweety's house. It carries up to nine hundred million gallons of water per day; thirty-seven million per hour and all of it under high pressure.

The tunnel, built from 1939 through '42 was last shut down completely in 1958. For the last fiftysome years it's been running near capacity, twentyfour hours a day, every day of the week, month and year, and with all the budgetary constraints and cutbacks, maintenance was first "deferred," then ignored. Consequently, the engineers couldn't guarantee the tunnel wouldn't collapse if the water was

DEP management was terrified. They knew the Warwarsing section of the tunnel was plagued with problems . . . problems lacking solutions. To begin with, this section of tunnel went through an area with excessive groundwater. Then there was all the shale: a type of rock the tunnel drivers and geologists called "rotten" because of its tendency to flake into small pieces at the slightest pressure. Added to

those problems was the fact that, for whatever reasons, the general contractor had been allowed to mine and mix his own concrete aggregate, "to City specifications," and the whole section of tunnel reinforced with steel "rebar." Folks living in Warwarsing had been complaining about water leaks to City officials for twenty years. The City had been denying and obfuscating the facts of the issue and ignoring the complaints for an equal amount of time.




