The Bats are Back!



At first we thought it was the creepy Halloween decorations attracted a few bats and their families to our daughter's front porch. day after The Halloween, Janna called to tell us that she was quite surprised to see the bats flying in and out of the spider

webs that donned the porch. She was even more surprised to see that the high cathedral window over the front door was completely cleaned of the bugs that had collected on the outer panes! She watched the little brown bats scavaging every last bug!

In cultures all over the world, the peculiar characteristics of bats has captured the imagination of storytellers who claim they have mysterious and supernatural qualities giving the little bats a notorious, sinister reputation. Having them appear when they did added a spooky touch to Halloween!

But a little research revealed that Janna was lucky to have these great little flying mammals make their abode at her residence.

These little brown bats, (Myotis lucifugus) are efficient little hunters and are known to make up to 1600 dives an hour over a thirty mile circle and eat their weight in insects each night before returning to roost at daybreak!

The small brown bats that are now 'hanging out"

where they could huddle in a group for the winter surviving off their fat reserves. These small brown bats have also been known to find comfort in homes that provide suitable conditions similar to the cave habitat during the winter. They usually look for homes that have cinder block or rock foundations as the walls are just what the bat needs to maintain the optimal hibernating temperature of 35-45 degrees Fahrenheit.

Some bat facts: Bats are the only flying mammals (flying squirrels glide) that evolved to conquer the air ten million years ago and took advantage of the

great food supply of night-flying insects.

Most bats have a breeding season, which is in the spring for species living in a temperate climate. Bats may have one to three litters in a season, depending on the species and on environmental conditions, such as the availability of food and roost sites. Females generally have one offspring at a time, which could be a result of the mother's need to fly to feed while pregnant. Female bats nurse their young until they are nearly adult size, because a young bat cannot forage on its own until its wings are fully developed.

The teeth and skulls of fossil bats are monkey-like and suggest a common ancestor for both bats and primates which could mean that those flying visitors may be relatives swooping and diving erratically and cleaning a window or two, as they were looking for

insects!

No, it isn't that bad to find that a colony of bats have decided to spend the winter in Sundown, probably in the basement of our daughter's home. Yes, she is lucky in more ways than one. She won't have to climb a ladder to clean that high cathedral ceiling, nor will she have to call the pest control company and they certainly do add to the Halloween decor of her front porch!

Household Hints

Clean jars, containers, and vases

Do you cringe at the thought of cleaning out a mayonnaise, peanut butter, or mustard jar to reuse it? Or worse, getting the residue out of a slimy vase, decanter, or container? There is an easy way to handle these jobs. Fill the item with equal parts vinegar and warm, soapy water and let it stand for 10-15 minutes. If you're cleaning a bottle or jar, close it up and give it a few good shakes; otherwise use a bottle brush to scrape off the remains before thoroughly rinsing.





The second program opened City-owned lands and waters for the first time to more than 20 state-certified outdoor guides who provided professional tours to dozens of visitors. These programs are in addition to the traditional use of metal rowboats for fishing, which has been permitted for decades.

"Our efforts to encourage boating and guided outdoor recreation underscore DEP's commitment to support the Catskills' tourism economy," said "This year Commissioner Strickland. we've heard feedback from many boaters and vendors who said these programs offered a unique way to exercise, attract visitors, and enjoy the scenic beauty of the Catskills, and we look forward to finding new and responsible ways to expand recreational access in the years to come."

DEP issued 757 tags to boaters, including 505 kayaks, 189 canoes, 33 rowboats, 25 sailboats, and five sculls. Pepacton Reservoir attracted 461 boaters, the most of any reservoir, followed by 126 tags issued at Neversink, 108 at Cannonsville, and 62 at Schoharie. Nearly 63 percent of recreational boating tags were issued to residents of the five watershed counties, including Delaware, Greene, Schoharie, Sullivan, and Ulster. About 14 percent of tags were issued to residents of New York City or Long Island. Visitors from six states also received tags, including Alabama, Florida, Maryland, Massachusetts, New Jersey, and Pennsylvania.

After a successful expansion of recreational boating last year, the program was further enhanced this year by a new initia-tive allowing local businesses to rent kayaks and canoes from 10 launch sites alongside the four reservoirs. The seven businesses that participated rented more than 300 boats. The program was administered with significant help from the Catskill Watershed Corporation, which funded the acquisition of 30 storage racks for the rental boats. The Catskill Watershed Corporation also administered the process to vet and approve businesses that applied to participate in the rental program.

'Installing racks to allow boat rental vendors to safely store canoes and kayaks has made it easier for them to do business, and to attract people without boats of their own to get out and have fun on the water," said Catskill Watershed Corporation Executive Director, Alan Rosa. "The CWC is happy to have played a part in assisting small business, and introducing new boaters to this great sport."

The program also served as a new source of revenue for the local companies who rented boats to residents, tourists, and summer camp groups.

about the recreational boating program," said Jim Rafferty, who owns Bradley Boat Rentals and participated in the rental program at Neversink Reservoir. "New York City and the Catskill Watershed Corporation have provided the public with a wonderful recreational opportunity and their efforts are appreciated.

2013 marked the second year of the expanded recreational boating program, which followed a three-year pilot that began in 2009 at Cannonsville Reservoir. Prior to 2009, DEP only issued tags for metal rowboats that were used and stored at the reservoirs for the purpose of fishing. That original program remains popular, with more than 12,212 tags currently issued to anglers who have rowboats at the reservoirs. While many residents enjoy this traditional program, there is a waiting list at many reservoirs and tourists and casual visitors to the Catskills could not get access to the reservoirs. Regular water-quality monitoring at each of these reservoirs has shown no impact from recreational boating and DEP's invasive species experts surveyed every boat launch site this summer and found no sign of aquatic plants or animals that can harm drinking water quality. Every boat that is used on the reservoirs is required to be inspected and steam cleaned to avoid the spread of invasive species.

This year, DEP also began a new program for New York state-certified outdoor guides to use City-owned lands and reservoirs in the watershed for the first time ever. In total, 21 certified guides received permits to offer fishing, hunting, and hiking tours that have long been a that offered services on City-owned properties required certification from the New York State Department of Environmental Conservation. Among other guidelines, the state program requires all guides to be certified in first aid, CPR, and water safe-

ty. Guides also must pass a state exam. "As a licensed guide in the Catskills since 1983, I was really happy to hear about the new program to allow guided tours on DEP land," said Charles "Sonny" Somelofski, who runs Catskills Outdoor Adventures in Margaretville. "My customers from downstate, New Jersey, and Connecticut were also very excited, and many of our tours on the reservoirs this year yielded world-class brown trout. We appreciate the City's efforts to work closely with us and help promote tourism in the Catskill and Delaware watershed.'

DEP manages New York City's water supply, providing more than one billion gallons of water each day to more than 9 million residents, including 8.3 million in New York City, and residents of Ulster, Orange, Putnam, and Westchester counties. This water comes from the Catskill, Delaware, and Croton watersheds that extend more than 125 miles from the City, and the system comprises 19 reservoirs, three controlled lakes, and numerous tunnels and aqueducts. DEP employs nearly 6,000 employees, including almost 1,000 scientists, engineers, surveyors, watershed maintainers and others professionals in the upstate watershed. In addition to its \$68 million payroll and \$157 million in annual taxes paid in upstate counties, DEP has invested more than \$1.5 billion in watershed protection programs-including partnership organizations such as the Catskill Watershed Corporation and the Watershed Agricultural Council-that support sustainable farming practices, environmentally sensitive economic development, and local economic opportunity. In addition, DEP has a robust capital program with over \$14 billion in investments planned over the next 10 years that will create up to 3,000 construction-related jobs per year. 2013 as more and more people learned House Passes Legislation Including Gibson Bill on Vietnam Veterans-

Bill Represents First Step in Effort to Help Blue Water Navy Vietnam Veterans

Washington, DC - This evening, the House passed veterans legislation that included a bill written by Congressman Chris Gibson. This bill, H.R. 1494, the Blue Water Navy Ship Accountability Act, was introduced in April, and is part of the Congressman's effort to ensure Vietnam veterans get the benefits they have earned and deserve. The Blue Water Navy Ship Accountability Act was incorporated into H.R. 2189, which passed the House 404-1 today.

"Without question, we must do everything we can to get our nation's veterans the benefits they earned serving our nation. This responsibility is even more profound when the illnesses from which they are suffering are linked directly to their service," Congressman Gibson. "I have personally met with constituents who have had to fight with the Department of Veterans Affairs to try and receive coverage for some truly debilitating conditions and diseases. This bill is the first step in these claims being processed quickly, reducing what has become an absolutely unacceptable backlog at the VA.'

Under current law, Blue Water Navy hallmark of the Catskills. Outdoor guides Veterans who did not set foot in Vietnam or serve aboard ships that operated on the inland waterways of Vietnam between January 9, 1962 and May 7, 1975 have the burden of proof to demonstrate exposure to Agent Orange and the connection to their illnesses. These claims are decided on a case-bycase basis. The Bureau of Veterans Affairs maintains a list of U.S. Navy and Coast Guard ships that operated within the vicinity of Vietnam; however, this list is imperfect and not comprehensive. Some offshore vessels docked to the shore of Vietnam, operated in Vietnam's close coastal waters and sent smaller vessels ashore.

> Congressman Gibson's provision would require a comprehensive search to determine which ships are eligible for coverage under current law, reducing the wait time when new claims are filed. This would help Veterans who are currently sick or, in some cases, have died and claims are being made by their sur-viving families. The information must be compiled within one year, and provided to the Veterans Affairs Secretary, as well as be available publicly.

> In addition, Congressman Gibson's bill, H.R. 543, the Blue Water Navy Vietnam Veterans Act of 2013 would grant presumptive Agent Orange exposure status to US servicemembers who served in the territorial seas of Vietnam during the Vietnam War. Presumptive coverage would enable eligible veterans to receive Veterans Affairs benefits if they suffer from any of the diseases the U.S. government has linked to Agent Orange.

Standard & Poor's long-term credit ratings range from a top rating of 'AAA' to a low of 'D' for debt issues that are actually in default and for issuers who did not meet their financial obligations. Ulster County has retained its AA- rating every year since 2008, until this year's upgrade to AA.

DiNapoli: Quarter of Property Value in New York Considered Tax Exempt

More than 25 percent of real property value in New York is exempt from county, city and town property taxes, according to a report issued today by State Comptroller Thomas P. DiNapoli. The total value of these exempt properties is \$680 billion. The value increases to \$826 billion for properties exempt from more than one type of local government or

school district taxes.

"In an era of limited resources, the impact of property tax exemptions complicates the financial picture of our local governments," said DiNapoli. "In localities with higher exemptions, taxable prop-erty owners are often carrying a much higher burden. Local leaders will need to continue to find creative ways to offset these exemptions and must carefully weigh any decision to offer new exemp-tions. Syracuse is attempting to tackle this challenge head on and others can learn from its example.'

Stephanie A. Miner. "This is not an isolated problem and represents a major challenge as we deal with the changing economic model of cities. Our nonprofits demand and deserve top-quality public services, such as those provided by police, fire, and DPW, but do not contribute to their high cost. This report by Comptroller DiNapoli helps us better understand where we are today and how we can take action to deal with our changing financial landscape."

Across New York, DiNapoli's report noted the percentage of exempt property value ranges from less than 10 percent in several municipalities to more than 60

percent in others.

For cities, the percentage of exempt property value is highest in Rensselaer (65 percent); Ogdensburg (64 percent); Salamanca (63 percent); Ithaca (62 percent) and Troy (59 percent). Other cities with a notable percentage of exemp-tions. Albany (59 percent), Syracuse (51 percent); Buffalo (37 percent); and

Yonkers (36 percent). Towns have the greatest variation in terms of total exempt property value in the state, ranging from 1 percent in some communities to nearly 90 percent in others. However, many of the towns with a high percentage of exemptions are smaller communities with special circumstances. For example, the town of Alfred in Allegany County has two large universities; the towns of Harrisburg and Martinsburg in Lewis County both provide multiple exemptions for solar and wind projects. Other examples include exemptions provided for state prisons, power plants, Native American reservations and federal military bases.

For counties, the highest percentage of exempt property value is in Tompkins County (40 percent), followed by Seneca (38 percent); St. Lawrence (38 percent); Lewis (37 percent); and Niagara (36 percent).

The report noted that exemptions generally fell into several categories:

* Government-owned property (federal, state, local and foreign governments) accounts for 41 percent, or \$343 billion, of the total value of exempt

property in the state:

* Residential property exemptions are the largest tax exemption in the state (28) percent of total exemptions valued at \$224 billion), but the majority of this total includes the state's School Tax Relief (STAR) program, which exempts a portion of school taxes on a primary residence and puts no direct additional burden on taxable property;

* Non-profit organizations, which include churches, hospitals and universities, total 14 percent (\$112 billion) of New York's exempted property value;

* Industrial and commercial exemptions, which includes public authority property and exemptions granted by local Industrial Development Agencies, accounts for 9 percent (\$76 billion) of all exempt value; and

 * Agriculture, forest property, public subsidized housing and other exemptions together account for 9 percent of all exempt value (\$73 billion).

To offset these tax exemptions, local governments have taken a number of steps to generate revenue from exempt property owners. This includes charging fees for services, developing PILOT (payments in lieu of taxes) arrangements and reaching voluntary payment arrangements with non-profit groups.

For example, in 2012, 51 percent of the property value (nearly \$5 billion) in the City of Syracuse was tax-exempt. To help make up for the lost revenue, the city has reached service agreements with Syracuse University and two local

Gibson Joins Bipartisan Group in Introducing Bill to Protect Americans from Government Surveillance

Washington, DC - Congressman Chris Gibson announced today that he joined with a bipartisan group of members to legislation to restore Americans' privacy rights. H.R. 3361, the USA FREEDOM Act, would end the government's dragnet collection of phone records and will require greater oversight, transparency, and accountability with respect to domestic surveillance authori-

"I have been a strong critic of the National Security Agency (NSA) data collection program, including supporting an amendment in July that would have defunded the NSA program responsible for the collection of data on Americans. This is in addition to having voted against reauthorizations of parts of the PATRIOT Act and Foreign Surveillance Act since I have been in Congress because of longstanding concerns about their unconstitutional authority," said Congressman Gibson. "Today's legislation is an important step forward and it's a step supported by a bipartisan group in the House and Senate. I refuse to accept the false choice that we have to give up our civil liberties and the rights that define us as Americans to remain safe. I will be strongly advocating for swift passage of this legislation."

The USA FREEDOM Act ends the bulk collection of data under Section 215 of the Patriot Act. In addition to ending the phone record collection, the USA Freedom Act would include the following

 Strengthen prohibitions against targeting the communications of Americans and would require the government to more aggressively delete information accidentally collected on Americans.

Increases the transparency of the Foreign Intelligence Surveillance Court (FISC) and creates the Office of the Special Advocate tasked with arguing for stronger privacy protections before the FISA Court and is vested with the authority to appeal decisions.

· Expand the power of the existing Privacy and Civil Liberties Oversight Board to include subpoena power to investigate issues related to privacy and national security.

 Allow internet and telecom companies like Google, Microsoft and Facebook to publically reveal more statistics about the information they turn over to the govern-

 Require the government to make semiannual public reports estimating the number of individuals that were subject to FISA orders authorizing electronic surveillance.

During the week of November 9-15, 2013, ULSTER COUNTY DEM WOMEN will be taking on the SNAP Challenge. Will you join us?

THE HUNGER DILEMMA:

There is enough food grown in the Hudson Valley to feed our community. However, costs related to storage, transportation, and access remain obstacles to distribution. Many of our neighbors-including children--remain hungry each day, relying on the Supplemental Nutrition Assistance Program (aka food stamps) for subsistence. Their daily benefit is only \$4.80 a day -- a woefully unrealistic budget considering the cost of food, preparation, and access to grocery stores. And it's getting worse: Congress recently voted to cut SNAP benefits for all participants starting November 1st. As an example, benefits for a family of four will decrease \$36 per month--the equivalent of taking away 21 meals per month.

Ulster County Dem Women are mobilizing to prevent further cuts to the Supplemental Nutrition Assistance Program, and to join efforts already underway to raise awareness of--and ultimately end--hunger in our community. Our first step is to take the SNAP Challenge!

WHAT IS THE SNAP CHALLENGE?

The Supplemental Nutrition Assistance Program (SNAP) feeds millions of hungry families in America every month. The average benefit per person is \$4.80/day and the Challenge asks people who participate to live within those means in order to experience first hand what relying on SNAP is like. These benefits are sometimes a family's only access to food.

THE RULES

1. Each Person should only spend \$4.80 per day on food and drink.

2. All food purchased and eaten in this time must be counted in total spendingthis includes dining out.

During this time, do not eat any food purchased prior to the start of the

Challenge.

Whenever possible, avoid accepting free food from family, friends and coworkers since these opportunities are not always available to those in need.

Eat as healthily as possible, keeping in mind that this is how many people eat every day, whereas you can make up for lost nutrients next week.







House Passes Bipa-Water rtisan Resources Act Legislation Includes Provi-Beneficial sions Upstate New York

The House passed the Water Resources Reform and Development Act this evening by an overwhelming bipartisan vote of 417-3. The Water Resources Reform and Development Act (WRRDA) is the water equivalent to the surface transportation bill and governs the oversight and authorization for various projects across the country. These projects are primarily conducted by the Army Corps of Engineer.

WRRDA is made up of grant and loan programs, project authorizations and includes efforts to mitigate flooding risks, improve drinking water, support water transportation, and protect wildlife. WRRDA also strengthens our water transportation networks to promote America's competitiveness, prosperity, and economic growth.

Congressman Gibson voted in support of the bill, which included reforms to dam safety programs championed by Congressmen Gibson and Sean Patrick Maloney, who coauthored standalone legislation to

reauthorize the Dam Safety Program. "In a district with significant water interests, this legislation is critical to help prevent flooding and institute important safety improvements and infrastructure projects. My Congressional District is compromised of three watersheds, one of the country's most important rivers, and communities inside and near flood plains. All of these interests will benefit from the critical reforms included in this legislation, which also enjoys strong support from the Governor's office, our family farms, small businesses, and many labor groups," said Congressman Gibson. This is an example of effective bipartisan work at the Committee level and I look forward to swift reconciliation with the Senate so that we can get this bill enacted into law."

Specific to NY-19, provisions in WRRDA include:

Superstorm Sandy: Requires a study authorized under the Sandy Supplemental Appropriations Act to include recommendations for disaster response and mitigation improvements. Specifically requires review of emergency response to natural disasters, both rebuilding to previous specifications and to a level of protection for future events.

Levee Safety: Authorizes federal technical assistance to states for levee safety programs as long as the state in question provides a minimum level of matching funding. These funds are tied to the requirement for federal levee safety guidelines.

· Flood Control: Allows the Corps to put into place a non-federal plan, at the request of a non-federal interest, to provide greater flood risk protections, if economically and environmentally favorable, to be funded by the non-federal interest.

Dam Safety: Reauthorizes the National Dam Safety Program, including authorizing representatives from non-governmental organizations on the Dam Safety Board and requiring that board to develop and implement a comprehensive dam safety hazard education and public awareness initiative to assist the public in mitigating against, preparing for, responding to, and recovering from dam incidents.

Gillibrand, Schumer Bill Urge Farm Conference Com-mittee to Keep Exemption for Shipments Bulk Apples from Inspection-Exemption Would Eli-minate Costly After-Hours Inspection Procedures New York Apple Exporters Would Save \$550,000 Annually if Inspection Eliminated Farm Bill was Conference Committee Begins

Negotiations Today U.S. Senators Kirsten Gillibrand, a member of the President's Export Council and member of the Senate Agriculture Committee, and Charles E. Schumer today urged the Farm Bill Conference Committee to keep a measure in the final Farm Bill that would exempt bulk shipments of apples to Canada from inspection. Fixing this would help New York apple growers streamline operations and save money. Exempting bulk shipments of U.S. apples to Canada from inspection required by the Apple Export Act would offer growers immediate savings of approximately \$300 per truckload, and allow growers to create their own distribution schedules, eliminating costly

after-hours inspection procedures. "New York State is home to some of the world's best apples and hardest working growers," said Senator Gillibrand. "Our farmers play a vital role in the economic development and food security of the state. The inspection of our apples to Canada is an impediment to New York apple exporters. The elimination of the expensive and unnecessary second inspection would put money back in

our local growers' pockets."
"Upstate New York apple producers are at the core of our Upstate New York economy, and this plan to exempt bulk apple shipments from a second inspection before heading to Canada makes good common sense," said Senator Schumer. "We must do all we can to protect our farmers from onerous and unnecessary costs, and I am urging my colleagues on the Farm Bill Conference Committee to keep this measure in the final bill."

The Apple and Pear Export Act of 1933 requires that all exported apples are inspected. However, pears have been excluded from the law since 1999. The elimination of apples from this antiquated law would enable apple farmers to have more control over their work schedules and would eliminate expensive

after-hours inspection procedures.
With nearly 2.5 million bushels of apples exported to Canada annually, this amendment to the current law could save U.S. apple growers over \$550,000 annually by allowing apple growers to distribute apple products on their own schedule saving valuable time and resources by avoiding onerous after-hours inspection proce-

New York is the second highest producer of apples, behind Washington State. In 2010, New York produced 1.26 billion pounds of apples, generating approximately \$227 million in revenue. 
